ARTICLES OF INCORPORATION

The undersigned persons acting as incorporators of a corporation under the Colorado Nonprofit Corporation Act sign and acknowledge the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is SOUTHWEST CENTER FOR INDEPENDENCE, INC.

SECOND: The period of duration is perpetual.

THIRD: This corporation is organized exclusively for charitable, educational and scientific purposes, including the provision of services for disabled persons.

FOURTH: The address of the initial registered office (and the principal office) of the corporation in Colorado is 288 Animas View Drive, #58, Durango, Colorado 81301, and the name of its initial registered agent at such address is Timothy L. Slane.

FIFTH: The number of directors constituting the original Board of Directors of the corporation is four (4), and the names and addresses of the persons who are to serve as the initial directors are:

SIXTH: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its member, director, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

**SEVENTH:** Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations exclusively for charitable, religious, educational, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1956, or any superceding section or sections thereof, as the Board of Directors shall determine. Any such asset not so disposed of shall be disposed by the State District Court of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

**EIGHTH:** The corporation services shall be available to all persons, requiring the corporation's services, regardless of race, color, creed, national origin, sex or handicap, and the corporation shall not discriminate against anyone on these grounds.
